- 1. Call to Order of the 72nd Annual Business Meeting of MSPE

At the time of commencement of the meeting, 41 members were in attendance, plus one (1) representative from NSPE and one (1) guest N. Robert Uddin, NSPE Delegate, led the invocation. Scott Conners led a moment of silence for members deceased within the past year.
  - President Conners gave brief opening remarks.
  - Lara Laird gave an overview of Frontline's management of MSPE.
- 2. Officer / Committee Reports
  - The minutes from the May 4th, 2018 Annual Business Meeting at the Eberhard Center, Grand Valley State University, Grand Rapids, Michigan were presented for approval by Secretary Kate Hennicken. There were no member questions. It was moved by Patrick Lewis and supported by Don Nedervelt to approve the minutes, and the motion was passed unanimously.
  - The 2018 financial report was presented for approval by Treasurer Kurt LaFrance. There were no member questions. It was moved by Don Nedervelt and supported by Leanne Panduren to approve the financial report, and the motion was passed unanimously.
  - Board and committee reports were included in the agenda packet that was distributed electronically to the membership. There were no member questions, and no action was required.

#### B. Building Fund:

The MSPE building was sold in 2018 and the proceeds of \$243,528.25 were invested at the direction of the building fund committee. The balance as of December 31, 2018 was \$235,176.78. As of the end of 2019 the building fund had a balance of \$282,351.67, for an annual gain of \$47,174.89. The building fund provided \$6,000 in operating revenue to MSPE in 2019.

#### C. Scholarship Fund:

The scholarship fund is invested with Nicholas Funds. The balance as of December 31, 2018 was \$180,683.40. As of December 31, 2019, the balance was \$231,518.76, for a gain of \$50,835.36. The scholarship fund provided \$9,000 to fund scholarships in 2019.

#### D. Profit & Loss Statement:

We ended the year with an operating gain (not including the building fund) of \$1,806.70. Our income was \$116,114.39 and our expenses were (\$114,307.69).

#### 1. **Profit & Loss Statement:**

MSPE is administering the funds for chapters that do not have an active 501(c)(6) tax determination from the IRS. These funds are available for use by the chapters with submission of receipts and are reported to the IRS on MSPE's tax filings. The chapters maintain the following balances:

Three scholarships were awarded to local students during the 2019 Scholarship Luncheon and Officer investiture, who were sworn in by Amanda Hemeyer, PE. # Western Region

#### Muskegon Chapter:

The Muskegon Chapter continued its proud tradition of strong support and administration of college scholarships and a robust MATHCOUNTS competition and outstanding programs. The programs included:

- Veolia Fish Farming Presentation

Two additional programs on the Consumers Energy Pump Storage Facility and the Badger Car Ferry presentation were cancelled due to the Coronavirus pandemic.

The MATHCOUNTS competition had nine schools participate with a total of 64 students. During the Countdown Round, the remaining students participated in an engineering activity building towers out of spaghetti and marshmallows.

Twelve applications were reviewed and submitted for the MSPE state scholarship with a successful applicant receiving a scholarship to Grand Valley State University. In addition, five applications were submitted for award of a Muskegon Area Community Foundation Scholarship for a Muskegon Community College student transferring to a four-year engineering degree program.

# Southwestern Chapter:

Chapter Board meetings were held monthly and a full slate of officers were in place for the 2019-2020 year. The Southwestern Chapter continued its strong support of the Scholarship program and MATHCOUNTS. The Southwestern Chapter reviewed and submitted nine scholarship applications on to the state scholarship program. Their long-established golf outing to support their scholarship efforts continued in the 2019-2020 year with over 75 golfers participating. In addition, they will be awarding local scholarships through their chapter.

The MATHCOUNTS competition featured twelve schools with 102 students competing at the event. The chapter helped organize their annual Engineers Week dinner at Western Michigan University with approximately 250 attendees with a much higher percentage of professionals than previous years. The dinner featured the topic of "Space Weather Impacts on Human Exploration of Mars".

#### Western Chapter:

The Western Chapter continued its strong presence with MSPE and continues to thrive with outstanding support and participation by all involved. The Chapter held meetings to confirm and finalize details for their chapter meetings and newsletter. Chapter meeting topics included:

# **Awards Committee**

The Awards Committee reviewed annual reports from the six (6) chapters that submitted them and reviewed multiple applications for both Engineer of the Year and Young Engineer of the Year. Both individual honors will be awarded this year at the annual virtual conference. Chapter awards will be given out in seven (7) categories as well, divided into small and large chapters, with three (3) chapters in each category. All chapters submitting reports won at least one award, and there was significant activity, innovation, and individual member value clearly offered by each.

# **Building Fund Advisory Committee**

The Building Fund Advisory Committee exists to oversee the investment proceeds following the sale of the MSPE Walnut St. Office Building in 2018. The committee is established by Bylaw 12 and guided by the board approved Investment Policy Statement (IPS). The committee continues to meet quarterly and monitor performance. A monthly reporting structure exists with distribution to Kurt LaFrance, MSPE Treasurer, and accountant Mary Beth Schenden. The fund balance as of April 17, 2019, the previous annual report, was \$263,644. Over the past 12 months, the fund distributed \$6,000 to the MSPE general fund on an annual request (October 2019) of the MSPE treasurer and in accordance with the Bylaws. The fund was rebalanced in January 2020 in accordance with the fund allocations in the IPS.

The fund balance peaked on February 19, 2020 with a balance of \$293,065. Following the peak, the investment markets have been extremely volatile in the wake of the COVID-19 outbreak. At the date of this report the fund balance was down over 30% to \$233,430 (March 25, 2020). While this decline reflects similar declines in broader financial markets, the committee remains committed to the allocations dictated in the IPS and remains optimistic that markets and fund balance will recover as the global pandemic subsides and economic activity resumes. As of this report (April 7, 2020) fund balance stands at \$245,734. Based on fundamentals of the investments and sustainable nature of the IPS, the committee remains confident that this fund will continue to perform its function and distribute a percentage of proceeds to the Society indefinitely.

# **Constitution & Bylaws Committee**

# **Education Committee**

The 2020 Annual Conference was scheduled to be held at Shanty Creek Resort in Bellaire, Michigan on May 6-8. Due to the COVID-19 pandemic, MSPE quickly converted the conference to a virtual format. It will be comprised of 3 half-day events that will provide attendees the opportunity to earn at least 9 PDHs.

The 2021 conference will be held at Shanty Creek Resort on May 6-7, 2021.

# Legislative & Governmental Affairs Committee

The Legislative and Governmental Affairs (L&GA) Committee met via conference call and communicated via email during the year. The committee also includes all members of the PAC Board so that the two groups can actively discuss legislation and potential legislator support, although the PAC Board votes on donations are taken separately. In 2019, the decision was made to have the Chair position on this committee run in conjunction with the Michigan Legislative cycle for continuity. The next Chair will take over in January 2021.

The L&GA Committee also works through the Architects, Engineers, and Surveyors Joint Legislative Coalition (AESLC) through our delegates John Condie, PE; Leanne Panduren, PE; Jay Wheeler, PE and Ryan Roth (Frontline). AESLC consists of representatives from MSPE, AIA-M, ACEC-M and MSPS and meets regularly with our lobbyist (Kelley Cawthorne) to discuss issues that the coalition wants to monitor/push during each legislative session. In addition, this allows the groups to collaborate on the use of PAC funds and making our limited funds have greater impact.

The 2019-2020 cycle has been an active one for MSPE with continued work to support our Certificate of Merit legislation. This has been an uphill battle and we have had several meetings with committee members and other legislators but have been unable to get the bill passed out of Committee. We have also spent considerable time meeting with legislators regarding bills we opposed as written that targeted felony exclusions for licensure (good morale character bills) and changes to the requirements for professionals in the design/build industry. We continue to work on these bills to get the bill language modified. To date none have been voted out of Committees. The legislature was focused in the fall months on the budget and the Governor's line item vetoes and use of executive powers in relation to the budget. This sidetracked progress on bills we supported and opposed. In addition, there has been much discussion which we have participated in regarding long-term transportation funding. While no resolutions have been reached, some transportation bills were passed.

We hoped to see movement on bills we are focused on when session resumed in early 2020; however, other topics have taken precedence and the focus for much of March was on the pandemic and the

state's response. The remainder of the session is likely to be volatile as it is unclear when normal sessions and committee meetings will resume and legislators will likely spend the summer and early fall months campaigning prior to the November election. Late November/early December will bring us another lame duck session and MSPE will need to be ready to react quickly.

While the committee discussed many bills that were introduced, following is a list of those we were actively working on over the past year:

- HB 4495, HB 5279-5280/SB 684 Design Build
- HB 4488 Felony Exclusions for Licensure
- HB 4100 Historic Tax Credit Reinstatement
- HB 4696-4973/SB 515-524 Transportation
- HB 5169 Certificate of Merit

This year's AESLC Legislative Day had to be postponed due to the COVID-19 pandemic. At this time, we are still hopeful we will be able to conduct our visits with legislators at our rescheduled date in early June.

# **MATHCOUNTS** Committee

At the 2019 National Competition the Michigan team finished 25th of 56 teams. The following Mathletes represented Michigan at the National Competition in Orlando, FL on May 12th & 13th, 2019:

While our team members did not finish as high as Michigan teams in the past, they did an excellent job considering they were the youngest overall team in the competition.

The 2019-2020 Competition year was very successful through the end of the Chapter Competitions in February. There was even a perfect score on the Chapter Test by former National Mathlete Vikram Goddla from Country Day Middle School. A total of 137 students qualified to advance to the State Competition, scheduled for Pi Day, March 14th at Saginaw Valley State University. However, the Coronavirus outbreak played spoiler. In light of the rapid spread, MSPE and the National MATHCOUNTS Organization both determined independently that the risk to the students required the State Competition to be postponed indefinitely. The National Foundation Board announced on March 20th that the National Competition for 2020 was cancelled, as were all un-held State Competitions.

With the assistance of the Chapter Coordinators, I identified the top 30 students in the state based on their chapter scores. The Top 6 students are listed below, they are ranked based on the tie breakers established in the MATHCOUNTS Handbook:

# **Membership Committee**

The Membership Committee met via phone call every other monthly over the past year. The group is comprised of 35 people (email distribution list) and includes chapter membership chairs, chapter presidents, regional VPs, and a few at-large personnel. Typically, meetings were generally 2-4 people throughout the year. As of April 2020, MSPE had 1010 members, which is an increase of 59 members from April 2019 (951 members). The growth may seem impressive; however, a large portion of this group are student members, as the high school scholarship application requires these high school students to join. This also effects why we have a large drop rate each year. We had an increase of 2 paying member (Standard members & Enterprise members) over the same time period. We are optimistic that we are beginning to reverse the trend of lost membership from 2017. Over the next year we hope to improve upon the following:

- 1. Tracking membership trends on a quarterly basis (chapter membership, standard member, etc.)
- 2. Reducing the number of "unassigned" members to actual chapters (currently 36 although almost everyone is a student member)
- 3. Reduce the number of dropped members for a 12-month period (currently 47)
- 4. Increase Standard and Enterprise members (currently 586)
- 5. Reach out to past MSPE members that are PE and EITs and ask them to rejoin.

- We Rank 6 in the most Life members
- We Rank 8 in the most Retired members
- We Rank 2 in the most Student members
- We Rank 6 in the most Paying members
- We Rank 5 in the most Overall members of any state
- We Rank 9th in the percentage of engineers that are members.
- There are 9,014 Engineers in the state and 9% are MSPE members

The MSPE PAC remains a vital part of our Society. We responded to several requests within the past year to legislators in key positions to help support our lobbying efforts. All checks received by our PAC are from individual donors. The PAC Board meets on a quarterly basis and on an as-needed basis to vote and disburse funds. Our starting balance on March 31, 2019 was \$806.19 and our ending balance on March 31, 2020 was \$2699.19. We are currently fundraising and working with our MSPE Lobbyist and AESLC Committee to identify opportunities to gain maximum impact for the MSPE membership.

# **Scholarship Committee**

Each year the MSPE Scholarship Committee evaluates and awards scholarships to students, focusing primarily on graduating High School Seniors planning to attend a Michigan ABET accredited college engineering program starting in the fall semester. This year, 110 graduating high school seniors applied for 22 scholarships valued at \$36,000 with \$16,000 of that amount funded by MSPE. In addition to MSPE, the scholarships were sponsored by Grand Valley State University, Kettering University, Lake Superior State University, Michigan Technological University, Saginaw Valley State University, University of Michigan – Ann Arbor, University of Michigan – Dearborn, Wayne State University, and Western Michigan University. For the high school program, application forms were revised and made available at the MSPE website in the fall of 2019. Applications were due to the Chapter Scholarship chairs by February 5, 2020. The Scholarship Committee reviewed the applications and identified proposed recipients for each scholarship. Award letters will be sent out notifying the winners by late April 2020, and final awards will be completed by the end of May 2020.

Additionally, one to four scholarships have been awarded in the past to college undergraduate students currently enrolled in a Michigan ABET accredited college engineering program. Due to financial constraints, the committee did not offer any college undergraduate scholarships.

This year's scholarship program was well received by participating Universities and Colleges and has continued to be a successful program sponsored by MSPE.

# **Strategic Plan & Goals Committee**
